Position: We are looking for casual staff to help support providing residential and commercial waste audit services from Furry Creek to Squamish.

Squamish CAN is looking for someone detail-oriented and flexible to assist with commercial and residential waste audits throughout the year. Ideal candidates are passionate about zero waste and good with public education.

Roles and Responsibilities

- Assist with setting up, auditing, and cleanup for commercial waste audits at various locations within the Sea-to-Sky.
- Record and analyze waste data, such as volumes and types of materials, to identify areas for improvement in waste management processes.
- Identify and categorize different waste streams (e.g., recyclables, organics, landfill waste) and assess their effectiveness.
- Operate basic waste audit tools and equipment, including scales, sorting stations, and data recording devices.
- Communicate effectively with members of the public about waste audits and waste disposal programmes in the Sea-to-Sky area.
- Track hours and all expenses for each audit.
- Ensure personal and team safety is a priority.

Required Competencies and Qualifications

- Able to stand for long periods, walk long distances, lift up to 50 lbs, and work outdoors.
- Capacity to identify issues in waste management processes and propose practical solutions.
- General understanding of waste and recycling bylaws.
- Willingness to work closely with team members and clients to improve multi-family, institutional and business waste management systems.
- Comfortable using basic tools and equipment, such as scales, sorting stations, and data recording software.
- Be available mostly weekdays, with some work on weekends.
- Ability to get to and from work sites from Squamish to Furry Creek and Whistler.
